With the advent of high-resolution satellite systems in stereo, the theory of analytical photogrammetry restituting 2-D image information into 3D is of increasing importance, merging the remote sensing approach with that of photogrammetry. The result of the restitution is a direct input into geographical information systems in vector or in raster form. The fundamentals of these are described in detail, with an emphasis on global, regional and local applications. For data integration, a short introduction into the GPS Satellite positioning system is added.
