In Libya and Syria, young Riad is exposed to the dismal reality of a life where food is scarce, children kill dogs for sport, and his cousins, virulently anti-Semitic and convinced he is Jewish because of his blond hair, lurk around every corner waiting to beat him up. In Volume 2, Riad, now settled in his father's hometown of Homs, gets to go to school, where he dedicates himself to becoming a true Syrian in the country of the dictator Hafez Al-Assad. Told simply yet with devastating effect, Riad's story takes in the sweep of politics, religion, and poverty, but is steered by acutely observed small moments: the daily sadism of his schoolteacher, the lure of the black market, with its menu of shame and subsistence, and the obsequiousness of his father in the company of those close to the regime. As his family strains to fit in, one chilling, barbaric act drives the Sattoufs to make the most dramatic of changes. Darkly funny and piercingly direct, The Arab of the Future, Volume 2 once again reveals the inner workings of a tormented country and a tormented family, delivered through Riad Sattouf's dazzlingly original talent.

First came the disintegration of the Ottoman Empire following World War I; then, in the 1950s and '60s, the Nasser-inspired wave of Arab nationalism and socialism. The Arab world's third great political cataclysm of the past 100 years has also brought permanent changes, but not as its activists had hoped: the 2011 uprisings. Their consequences have differed greatly from area to area, splintering the Arab region into four different worlds. The Levant states have disintegrated, possibly irreversibly. The Gulf monarchies have embarked on far-reaching plans of economic and social change to stave off discontent. Egypt has retreated into military authoritarianism and a war on Islamists, threatening its future stability. Only the Maghreb countries, which have started integrating Islamists into their political systems, offer some hope for progress toward democracy. Marina and David Ottaway have brought together fifty years of experience observing the Arab world, and a wealth of first-hand information gathered from living and travelling extensively in the region. A Tale of Four Worlds is an indispensable analysis of the profound upheavals that have shaken--and continue to transform--Arab and global politics.

The Foundations of the Arab State deals with the conceptual, historical, and cultural environment in which the contemporary Arab state system was established and has evolved. With contributions from established scholars in the

This book, first published in 1988, compiles selected contributions to a symposium on 'The Gulf and the Arab World' held by the Centre for Arab Gulf Studies at Exeter University, UK, in July 1986. The historical perspective was considered to be a prerequisite for focusing on modern developments, and two chapters are devoted to the coming of both the Arabs and Islam to the Gulf, and a further chapter examines the role of the Ottoman Empire in the region. The

remaining chapters concentrate on recent interaction under the broad headings of political and socio-political affairs, demographic aspects, financial interchange and questions of security. A large part of the book is devoted to detailed analysis of the main factor in Arab Gulf/Arab world relations: the huge flow, in one direction, of Arab migratory manpower and, in the reverse direction, of Gulf financing and workers' remittances.

Yet everywhere except Tunisia it led to either renewed dictatorship, civil war, extremist terror, or all three. This book explains Arab military responses to the social uprisings which began in 2011. Through a comparative case study analysis of Egyptian, Tunisian, Libyan, and Syrian militaries, it explains why militaries fractured, supported the regime in power, or removed their presidents.

One of the implications of Orientalism is that the Arab world, as a homogenous entity, is often analysed as an anomaly within the international system. This book argues that, despite their differences, societies across the globe ultimately construct their own history according to very similar dynamics and tensions. The methodological approach of this book, using different countries within the Arab world as models, offers the reader an analysis of relations between the elites and their opposition in a variety of settings. A definition of the political structure of each country is drawn from this analysis before potential future scenarios, as according to country specific experts, are proposed. This model provides a useful contribution to students and scholars of political science and international relations. Through providing a comparative study of the political regimes currently operating in the Arab world; their elites, civil society, power resources and political resistance, this book illustrates that despite the image of homogeneity sometimes portrayed by the Arab world, it is the multiplicity of models and heterogeneity of regimes that constitute reality.

Over recent decades we have witnessed the globalization of research. However, this has yet to

translate into a worldwide scientific network, across which competencies and resources can flow freely. Arab countries have strived to join this globalized world and become a 'knowledge economy,' yet little time has been invested in the region's fragmented scientific institutions; institutions that should provide opportunities for individuals to step out on the global stage. Knowledge Production in the Arab World investigates research practices in the Arab world, using multiple case studies from the region with particular focus on Lebanon and Jordan. It depicts the Janus-like face of Arab research, poised between the negative and the positive and faced with two potentially opposing strands; local relevance alongside its internationalization. The book critically assesses the role and dynamics of research and poses questions that are crucial to further our understanding of the very particular case of knowledge production in the Arab region. The book explores research's relevance and whom it serves, as well as the methodological flaws behind academic rankings and the meaning and application of key concepts such as knowledge society/economy. Providing a detailed and comprehensive examination of knowledge production in the Arab world, this book is of interest to students, scholars and policy makers working on the issues of research practices and status of science in contemporary developing countries.

The book considers the obstacles to the establishment of an effective Arab Gulf lobby in the US in order to reach an informed conclusion that evaluates the prospects of an effective Arab Gulf lobby. As one of the few academic research works on the Arab Lobby, this work will be of value to scholars and policy makers interested in US domestic politics and Arab American activism, as well as students of Middle Eastern Studies, Arab Gulf studies and communication and public relations, among others.

This introductory text assesses how agricultural, industrial and urban development has evolved in the Arab region. Contrasting Arab and Western interpretations of 'development', it draws on case studies covering states as diverse as Saudi Arabia, Yemen, Morocco and Jordan. The author suggests that until the Arabs define their own identity, there

will continue to be 'change' but not necessarily 'progress' in the region.

In the first volume, which covers the years 1978–1984, his family moves between rural France, Libya, and Syria, where they eventually settle in his father's native village of Ter Maaleh, near Homs. The second volume recounts young Riad's first year attending school in Syria (1984–1985), where he dedicates himself to becoming a true Syrian in the country of Hafez al-Assad. In this third volume, (1985–1987), Riad's mother, fed up with the grinding reality of daily life in the village, decides she cannot take it any longer. When she resolves to move back to France, young Riad sees his father torn between his wife's aspirations and the weight of family traditions.

This study surveys the many revolutionary attempts carried out against the Ottoman Empire in the Fertile Crescent and the Arabian Peninsula during World War I. Special emphasis is laid upon the subversive activities of the Arab secret societies which preceded the outbreak of Sharif Husayn's Arab revolt in 1916. The revolt is thoroughly examined and analyzed, regarding both its military operations and its human composition, which influenced its course. The story of a pivotal moment in modern world history, when representative democracy became a political option for Arabs—and how the West denied the opportunity. When Europe's Great War engulfed the Ottoman Empire, Arab nationalists rose in revolt against the Turks. The British supported the Arabs' fight for an independent state and sent an intelligence officer, T.E. Lawrence, to join Prince Faisal, leader of the Arab army and a descendant of the Prophet. In October 1918, Faisal, Lawrence, and the Arabs victoriously entered Damascus, where they declared a constitutional government in an independent Greater Syria. At the Paris Peace Conference, Faisal won the support of President Woodrow Wilson, who sent an American commission to Syria to survey the political aspirations of its people. However, other Entente leaders at Paris—and later San Remo—schemed against the Arab democracy, which they saw as a threat to their colonial rule. On March 8, 1920, the Syrian-Arab Congress declared independence and crowned Faisal king of a "representative monarchy." Rashid Rida, a leading Islamic thinker of the day, led the constituent assembly to establish equality for all citizens, including non-Muslims, under a full bill of rights. But France and Britain refused to recognize the Damascus government and instead imposed a system of mandates on the Arab provinces of the defeated Ottoman Empire, on the pretext that Arabs were not yet ready for self-government. Under such a mandate, the French invaded Syria in April 1920, crushing the Arab government and sending Faisal and Congress leaders in flight to exile. The fragile coalition of secular modernizers and Islamic reformers that might have established democracy in the Arab world was destroyed, with profound consequences that reverberate still. Using many previously untapped primary sources, including contemporary newspaper accounts and letters, minutes from the Syrian-Arab Congress, and diary and journal entries from participants, *How The West Stole Democracy From The Arabs* is a groundbreaking account of this extraordinary, brief moment of unity and hope—and of its destruction.
